Peg Taylor- spoke about the upcoming Mirror Lake Yard Sale

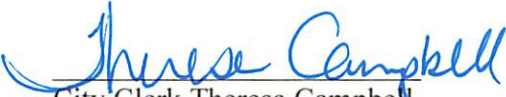
Kristy Chastain- mentioned that the incremental increases to the water bill is appreciated because it allows citizens the ability to budget for the new fees.
